ORDER ACCEPTING FINAL REPORT

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

- 1. On June 27, 2012, GVNW Consulting, Inc. ("GVNW"), the third-party KUSF administrator, filed a proposed list of sixteen (16) carriers that it would audit pursuant to K.S.A. 66-2010(b)(1) for KUSF Year 15. On July 30, 2012, the Commission approved GVNW's selections. GVNW subsequently audited the sixteen (16) carriers in Commission docketed proceedings.
- 2. On August 20, 2013, GVNW provided its Final Report summarizing the results of the sixteen carrier audits conducted for the period of March 2011 through February 2012. The Final Report describes the financial impact upon the KUSF as a result of its audits. The Final Report also contains several audit findings relating to revenue and assessments, customer surcharges, and other issues. No recommendations were included in the report.

3. The August 20, 2013, GVNW Final Report should be accepted by the Commission.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. The August 20, 2013, Final Report of GVNW in the above captioned matter is hereby accepted by the Commission.
- B. The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 77-529(a)(1).
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of issuing such further order, or orders, as it may deem necessary.
