### ORDER ACCEPTING REVISED FINAL REPORT

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed its files and record and being duly advised in the premises, the Commission makes the following findings:

- 1. On June 26, 2016, GVNW Consulting, Inc. (GVNW), the third-party Kansas Universal Service Fund (KUSF) administrator, filed a proposed list of sixteen (16) carriers that it would audit pursuant to K.S.A. 66-2010(b)(1) for KUSF Year 18. On July 7, 2015, the Commission approved GVNW's selections. GVNW subsequently audited the sixteen (16) carriers in Commission docketed proceedings.
- 2. On September 12, 2016, GVNW provided a Final Report summarizing the results of the sixteen (16) carrier audits conducted for the period of March 2014 through February 2015. On October 3, 2016, GVNW filed a Revised Final Report adding a third docket that remains open due to a compliance issue. The Revised Final Report describes the financial impact upon the KUSF as a result of its audits. The Revised Final Report also contains several audit findings relating to revenue and assessments, customer surcharges, and other issues.
- 3. The October 3, 2016 Revised Final Report should be accepted by the Commission.

#### IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. GVNW Consulting, Inc.'s October 3, 2016 Revised Final Report filed in the above captioned docket is accepted by the Commission.
- B. Parties have 15 days, plus three days if service is by mail, from the date this Order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 2015 Supp. 77-529(a)(1).
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of issuing such further order, or orders, as it may deem necessary.
