This filing is being made in compliance with the Federal Commerce Commission's ("FCC") November 18, 2011 Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc. (FCC 11-161), the FCC's April 25, 2012 Second Order on Reconsideration in WC Docket Nos. 10-90, etc., Order, DA 12-47, and the Illinois Commerce Commission's ("ICC") March 6, 2013 Order in Docket Nos. 11-210 and 11-0211 (Cons.). New Windsor Telephone Company and Reynolds Telephone Company are ISCECA tariff participants that are IITA Member Intervenor companies participating in the above-reference Docket.

In addition, Viola Home Telephone Company is being withdrawn from the ISCECA Illinois C.C. No. 1 Tariff and will be filing its own Intrastate Tariff.
