Enclosed for filing with the Commission are the original and two copies of the annual Illinois Small Company Exchange Carrier Association (ISCECA) Illinois C.C. No. 1 revised tariff pages.

Historically, this filing would be made in accordance with Federal Commerce Commission's ("FCC") November 18, 2011 Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc. (FCC 11-161), the FCC's April 25, 2012 Second Order on Reconsideration in WC Docket Nos. 10-90, etc., Order, DA 12-47, and the Illinois Commerce Commission's ("ICC") March 6, 2013 Order in Docket Nos. 11-210 and 11-0211 (Cons.). New Windsor Telephone Company and Reynolds Telephone Company are ISCECA tariff participants that are IITA Member Intervenor companies participating in the above-reference Docket. In compliance with the above-referenced FCC Orders, all non-recurring charges, fixed, terminating switched access rates and both originating and terminating Toll VoIP-PSTN rates are to be brought into parity with interstate switched access rates and in compliance with the above-referenced ICC Order, originating switched access rates are to be brought into parity with interstate access switched access rates for the above-referenced IITA Member Intervenor companies. Note that because there were no changes in interstate rates this year, no intrastate rate changes are required since the rates are already in parity.

This filing is solely being made to incorporate the following updates as a result of the FCC 8YY Access Charge Reform Order (WC Docket No. 18-156) released on October 9, 2020.

- 1. Bring any intrastate originating 8YY end office access rates that exceed the comparable interstate rates into parity with the comparable interstate rates.
- 2. Establish new Joint Tandem Switched Transport (JTST) Access Charge for tandem providers A single uniform nationwide rate cap of \$0.001 per minute for originating 8YY tandem switching and transport access charges.
- 3. 8YY Database query rates capped at the national average rate of \$0.004248 and will transition down over a three year period.
 - a. Effective July 1, 2021 \$.004248
 - b. Effective July 1, 2022 \$.002224
 - c. Effective July 1, 2023 \$.0002
