

LOCAL SERVICE REVENUE REPORTABLE TO THE KUSF

All intrastate retail service revenue similar to those listed and described below should be reported to the KUSF, regardless of technology (wireline, wireless, VoIP, etc). FCC Uniform System of Accounts, Part 32, accounts listed below provide guidance for reporting revenue. A Provider may use different account codes or names, however, comparable revenue must be reported.
